- \*Effective July 1, 2024 (SB165) candidates may begin collecting petition signatures on January first of the year in which the election is held.
- \*Signature Requirement: 125 signatures from qualified voters in the district you are seeking election.
- \* You do not need to file all petition pages at the same time.
- \*First page filed must be filed with the Declaration of Candidacy.
